This announcement is made by Atlinks Group Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on the GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined in the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571, Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders of the Company (“**Shareholders**”) and potential investors that, based on the preliminary assessment of the unaudited consolidated management accounts of the Company for the year ended 31 December 2018 and the information currently available to the Board, the Company is expected to record a loss for the year ended 31 December 2018 as compared to a profit (excluding the listing expenses) for the year ended 31 December 2017.

Despite the revenue of the Group for the year ended 31 December 2018 is expected to remain relatively stable as compared to that for the year ended 31 December 2017, the Board considers that the loss for the year ended 31 December 2018 was primarily attributable to the increase in selling and distribution expenses and administrative expenses mainly due to (i) the increase in legal and professional fees subsequent to the listing of the Company’s shares on GEM; and (ii) the increase in marketing costs as the Group has participated in more trade shows in various countries during the year.

The Company is in the process of finalizing its the unaudited consolidated financial results of the Group for the year ended 31 December 2018. The information contained in this announcement is only based on a preliminary assessment by the Board with reference to the information currently available to the Board and the unaudited consolidated management accounts of the Group for the year ended 31 December 2018, which are subject to finalisation and other potential adjustments, if any, and have not been audited or reviewed by the Company’s auditor or reviewed by the audit committee of the Company. Further information and other details of the Group’s financial performance for the year ended 31 December 2018 will be disclosed in the forthcoming annual results announcement, which is expected to be published on the website of the Company at www.atlinks.com and on the website of the Stock Exchange at www.hkex.com.hk in March 2019.

Shareholders and potential investors of the Company should exercise caution when dealing in the securities of the Company.
